

Details of the SWVAC Membership Fee Renewals and New Members for 2026 / 2027

For existing members the SWVAC membership fees were due to be renewed from **Monday 1st April 2026** and this will take your membership through until 31st March 2027.

If you are a new member then please complete an application form and pay the appropriate fee (£35.00 for 1st Claim or £12.00 for 2nd Claim) in one of the following methods.

Our SWVAC membership fees for the coming year are :-

1st Claim Members £35.00 (SWVAC pays your EA registration fee of £23.00 to England Athletics & your BMAF affiliation fee)

2nd Claim Members £12.00 (your 1st Claim club pays your EA registration fee to England Athletics, SWVAC pays your BMAF affiliation fee)

For existing members if your contact details haven't changed since you last renewed (name, address, telephone number, etc..) then you don't need to tell us but if they have please send us your new details on an email to stephenjlang54@gmail.com

There are 4 ways of paying :-

a) **Online Bank Transfer** to :-

Please put your name in the reference box and let us know by email when it's completed so we can look out for it on our account

b) **Card payment on the BMAF website** using the Stripe Payment system - this is now a lot more straightforward than it used to be. Go to this website <https://bmaf.opentrack.run/en-gb/> and put in your email and password (it will prompt you if you have forgotten it) and it has a yellow button labelled "Renew" for your account. Press this button and it will take you to the page where you can select to **renew** your membership of SWVAC and it will ask for your card (credit or debit) details and it will acknowledge the payment to you and the system will send us a message.

c) **Cheque** - please make it payable to South West Veterans Athletic Club for either £35.00 (1st Claim) or £12.00 (2nd Claim) and send it in the post to - **Steve Lang, 2 The Grange, Bolton Road, Edgworth, Turton, Lancs. BL7 0AW** along with a completed form or a brief note saying who it's for and any change of contact details.

d) **Standing Order** - you may already have one setup with your Bank, if you have you may need to change the amount at your Bank especially if you are a 1st Claim Member as the fee has increased this year but if you want to setup a new one then use the SWVAC Bank details in a) above. Please let us know that you have setup a standing order and what date the money is due to be paid to SWVAC with any change of contact details.
